In  s Cantante there is a section in the account phase where the interviewer has reviewed the details from the suspect and compared it with the evidence gathered, whether issues in their own statement or that if other evidence.The interviewer can then put to the suspect the discrepancies and ask the suspect for an explanation for the discrepancies. This sounds a simple process, but operationally, it requires skilled interviewing.Very few interviewers have the skill to conduct this phase without appropriate practical training and constructive feedback. The issue for the interviewer is identifying what is evidential detail and differentiating it from investigative information. With over 50 years of conducting investigative interviews, training advanced interviewing and more recently as an expert Court witness on investigative interviewing the same issues arise.Many interviewers are using open ended questioning but there is a continual lack of constructively using open questions to obtain detailed evidential answers.More emphasis in training on analysing the detail provided in answers.Questions do not prove or disprove the case answers do.

Good question **In  s Cantante**. I also study linguistics and cultural linguistics. The persuasion ability is a complete range, and also has to do with the interviewer's personality. Ask anyone in the investigations industry.

And for cultural literacy reference and orientation, we could show 1,000 investigators the same sets of four characters / personalities. Take two series, "True Detective" (2014) with characters Holden Ford and Bill Tench, and contrast with "Mindhunter" (2017-2019) and characters Rustin Cohle and Martin Hart...

Then we run a questionnaire (online, multiple choice) about investigator styles and personalities... I suspect we would see some interesting trends there.

IMHO... "persuasion ability" is the "catch all", the non-linear, the broader archetypes, the fuzzy logic, that (EI, emotional intelligence) that very much complements the linear, narrow minded approach of the scientific method.
