To Mr. Ramos and the Public Prosecutor of Portugal,

Re Intended Proceedings Between Colin Paul Gloster v João Ramos; Public Prosecutor of Portugal; and others

You perpetrated malicious falsehood and defamation on me.

Unfortunately you are abusing me since years ago. Misbehaviour of your remorselessness included inter alia:

- Vera Cristina da Silva Gomes de Oliveira of you illegally had had aggravated assaults perpetrated against me during 2013; and
- malicious falsehood covering up these aggravated assaults.

Your persistence at misbehaviour (e.g. an unfounded accusation against my health which led onto my being assaulted and hospitalised during Spring 2013; letting myself being tricked into signing a document (in a language which I do not comprehend and by lying to me about the meaning of this document) thereby depriving me of a lawyer against these aggravated assaults; and complicity with fabrication of perjury against me) instead of dispute resolution makes it inevitable that I shall sue you.

According to reporting by the journalist Fergal Henry mac Erlaine:

“[. . .]

João Ramos, a Coimbra Justice Department official, said last night that [this claimant . . .] was also charged with a crime of illicit recording.

[. . .]

The public prosecutor’s charging document accuses [this claimant . . .] of attempted first-degree murder. It states that he struck Ms Figueiredo after she opened the office door to him, shortly after she asked [this claimant . . .] to leave when he raised his voice.

[This claimant . . .] allegedly raised his voice “to a higher pitch in a menacing attitude” before placing his foot on the bottom of the door to keep it open.

[This claimant . . .] was accused of brandishing an axe he had concealed in his waistband before Ms Figueiredo was “struck repeatedly in the arms by the various blows the defendant directed to her chest”.

During a police interrogation in January 2015, [this claimant . . .] was found to have made an illegal recording, the charge document states.

According to reporting by the journalist Fergal Henry mac Erlaine:

“[. . .]

Justice Department official Joao Ramos, said last night the accused was also charged with a crime of illicit recording.

[. . .]

Papers from the public prosecution office state [this claimant . . .] is accused of attempted first-degree murder.

[. . .] The defendant [this claimant] reportedly has a history of mental illness.

[. . .]

During police questioning in January 2015 [this claimant . . .] was found to have made an illegal recording, the charge document

states.

[. . .]”

As you are aware (cf. Page 41 (“**Evil which is so-called science/whistleblowing is not a mental illness/Rui Miguel Curado da Silva had me assaulted as a result of printing this webpage.htm”)** of Portuguese Process Number 123/14.9PFCBR), you are at faults.

These dishonestly professed allegations about me you published meant and were understood to mean meanings including these:

- this claimant is immoral;
- this claimant deserves to be ridiculed for being an unreasonable bigot who lacks restraint because this claimant insists that he is “not unreasonable”;
- this claimant is hypocritical to denounce mistreatment only to replicate it because this claimant is known to profess austere morality (e.g. is against injustice within the science community);
- this claimant is not civilised;
- it is an act of madness;
- this claimant is not a calm person with emotional balance suitable for employment;
- this claimant was obviously mentally ill and needed help and has a mental illness and had insanity;
- this claimant did a thing which was not a justifiable thing to do;
- the victim is not this claimant, and this is also defamatory malicious falsehood for meaning that this claimant is not a victim;
- Professrix Maria Filomena de Osório Pinto dos Santos Figueiredo was not axed as partial retaliation as just cause over getting this claimant subjected to aggravated assaults in 2013 with the University of Coimbra; and the Public Prosecutor of Portugal being accomplices;
- this claimant has perpetrated this assault with a deadly weapon;
- this claimant is dangerous;
- this claimant deprived Professrix Maria Filomena de Osório Pinto dos Santos Figueiredo of a right to go to a safe workplace and not be assaulted (this claimant and a Portuguese criminal tribunal observe that the reality was contrary — this claimant had gone to a workplace where he was assaulted because of Professrix Maria Filomena de Osório Pinto dos Santos Figueiredo; the University of Coimbra; and the Public Prosecutor of Portugal);
- this claimant is a criminal at Level 1 of *Chase*;
- immoral harassment was not going on against this claimant;
- Professrix Maria Filomena de Osório Pinto dos Santos Figueiredo; the University of Coimbra; and the Public Prosecutor of Portugal are not at faults;
- this claimant is likely to menace students of the University of Coimbra by means of an axe;
- being an autist is being ill instead of being a member of a minority genetic race, or phrased differently: autism is an illness instead of a set of minority genetic races;
- autism is a dangerous illness;
- psychiatric evaluation was not a wild-goose chase cooked by Professrix Maria Filomena de Osório Pinto dos Santos Figueiredo; the University of Coimbra; and the Public Prosecutor of Portugal;
- this claimant is not a good workmate;
- Professrix Maria Filomena de Osório Pinto dos Santos Figueiredo and Coimbra University did not create unnecessary problems which this claimant tolerantly endured for many years, but the contrary instead;
- this claimant made a random attack on an innocent individual; and this is also defamatory malicious falsehood for meaning that Professrix Maria Filomena de Osório Pinto dos Santos Figueiredo was not involved with financially prejudicing this claimant, and this is also defamatory malicious falsehood for meaning that Professrix Maria Filomena de Osório Pinto dos Santos Figueiredo did not interfere with payment of a recent grant;
- the claimant has perpetrated this assault;
- the claimant has perpetrated this assault with a deadly weapon intended to kill;
- this claimant was not deprived of a PhD examination because of illegalities perpetrated against him;
- what this claimant did was serious;

- the axing was not partial retaliation;
- since years ago the Public Prosecutor of Portugal and Maria Filomena de Osório Pinto dos Santos Figueiredo do not perpetrate discriminatory bullying against this claimant on grounds such as race; language; religion; political or other opinion; national or social origin; association with a national minority; property; birth or other status;  
and
- attempting recording was not attempting legitimate would-had-been self-defence.

These allegations amount to malicious falsehood and defamation on me and have caused me considerable distress and embarrassment. Allegations made against me by you are false and your interference with my right to deserved reputation and life is unjustified.

In the circumstances, I require de you full and unequivocal public retractions and apologies in terms to be approved by me, stating in open court; convictions of criminals; an undertaking not to repeat these allegations; refunds of monies that I paid to the putative University of Coimbra; the social security of my 1st Portuguese contract; a fair PhD examination; a Ph.D.; salaries for 2011 onwards for me as a Ph.D. holder; and thorough answers to requests I made. I am entitled to substantial compensation for the injury to my reputation and feelings, as to which I invite your proposals. In respect of damages I will point to the following facts and matters:

- you have exploited the fact that the criminal judge Rosa Pinto does not understand the words in English in **Evil\_which\_is\_so-called\_science/whistleblowing\_is\_not\_a\_mental\_illness/Rui\_Miguel\_Curado\_da\_Silva\_had\_me\_assaulted\_as\_a\_result\_of\_printing\_this\_webpage.htm** and in **This\_is\_not\_your\_country!\_Go\_back\_to\_Ireland!\_filename\_Recording\_20140804\_101602.3gpp**;
- a police officer said that what I did was not “serious”;
- you are perverts who dishonestly prejudice me since years ago;
- you deliberately utilise crimes against me and you deliberately avoid documenting that they are crimes;
- you are vicariously liable for Mr. Ramos;
- it is very clear to you that this claimant did not attempt to kill;
- you evil perverts had sent me on a dangerous wild-goose chase in bad faith and you are aware of this;
- you had and have perpetrated and perpetrate illegalities against me with the purpose of sabotaging my livelihood and reputation;
- a publishee refused to employ me;  
and
- the facts that you do not persist with charging me over attempted recording; persons including police officers and judges and you and witnesses and quacks had lied about me; police had perpetrated crime against me; the police station where I allegedly illegally recorded had provided you with documentation which you had used to illegally get a court order to perpetrate illegalities against me; and you manipulate media to conceal illegalities against me

I will also require payment by you of all the legal costs I have incurred in this matter.

This letter is typed in accordance with the Pre-action Protocol for Defamation. Please respond without another delay. If I would not have received a satisfactory reply by you via courier or registered mail to R da Sofia, 139-2° Posterior, 3000-387 Coimbra by February 2005 (given your connivances at the unreasonableness of a request by the European Space Agency to travel backwards through time) or if you would confess that a time machine is not real and that Maria Filomena de Osório Pinto dos Santos Figueiredo is not a true physicist, then by the morning of 25/05/2017, then do not be surprised if a claim form would be served upon you over this. Indicate to me as soon as is practicable, the name or names and address of a lawyer or lawyers of the jurisdiction of England and Wales who will accept service of proceedings on thy behalf should that eventuality arise. In the meantime, I reserve all my rights.
