Re Intended Proceedings Between Nicholas Collin Paul de Gloucester (Colin Paul Gloster) versus Global Notícias - Media Group S.A.; Person(s) Unknown of Global Notícias - Media Group S.A.; and others

To Global Notícias - Media Group S.A. and Person(s) Unknown of Global Notícias - Media Group S.A.,

Professrix Maria Filomena de Osório Pinto dos Santos Figueiredo defamed me during 2013 and she caused myself to be subjected to aggravated assaults during 2013 with the University of Coimbra; the Foundation for Science and Technology; and the Public Prosecutor of Portugal being accomplices.

These words complained of were published in England and Wales during 2016:

“A Coimbra University employee told local paper *Jornal de Noticias*[sic]: “He was completely anti-social. He never greeted anyone.””

During 2017 I also noticed publication in that jurisdiction of these words complained of:

“An employee at the college told local paper *Jornal de Noticias*: 'He was completely anti-social. He never greeted anyone.'”

(That misspelling of your newspaper name *Jornal de Noticias* is not by me.)

Who are the persons who perpetrated malicious falsehood and defamation on me?

If you would prefer alternative dispute resolution as an alternative to being sued by me, please suggest how we could resolve difficulties which you have caused. You would need to guarantee me that I would not become victimised by another criminal act for attempting alternative dispute resolution.

These dishonestly professed allegations about me you published meant and were understood to mean meanings including these:

- this claimant is immoral;
 - this claimant is selfish and inconsiderate towards others;
 - this claimant is not civilised;
 - this claimant is not a good workmate;
- and
- this claimant always greets nobody.

These allegations amount to malicious falsehood and defamation on me and have caused me considerable distress and embarrassment. Allegations made against me by you are false and your interference with my right to deserved reputation and life is unjustified.

In the circumstances, I require de you a full and unequivocal public retraction and apology in terms to be approved by me, stating in open court and an undertaking not to repeat these allegations. I am entitled to substantial compensation for the injury to my reputation and feelings, as to which I invite your proposals. In respect of damages I will point to the following facts and matters:

- Global Notícias - Media Group S.A. is vicariously liable for each employee of Global Notícias - Media Group S.A.;
 - you perpetrated and perpetrate illegality against me with the effects of sabotaging my livelihood and reputation;
- and
- it was trivial (e.g. by searching on the Internet) to refute the false fact of never greeting.

I will also require payment by you of all the legal costs I have incurred in this matter.

This letter is typed in accordance with the Pre-action Protocol for Defamation. Please respond without another delay. I request that I will receive a satisfactory reply by you via courier or registered mail to R da Sofia, 139-2º Posterior, 3000-387 Coimbra by the morning of 25/05/2017. Otherwise do not be surprised if a claim form would be served upon you over this. Indicate to me as soon as is practicable, the name or names and address of a lawyer or lawyers of the jurisdiction of England and Wales who will accept service of proceedings on behalves of yours should that eventuality arise. In the meantime, I reserve all my rights.
