It said the organisation was “deeply concerned” about the addition of the definition of “pharmacological restraint”, as it is a practice that “does not exist”.

“Psychiatrists and mental health professionals do not engage in administration of medication with the intention of ‘controlling a person’s behaviour’ as it is worded; or indeed with the intention to ‘restrict, prevent or limit the person’s freedom of movement or access to his or her own body’,” the letter said.

“It is deeply offensive to any practicing mental healthcare worker to feel that wording exists that suggests we administer medication under the terms of this definition. It is unclear what evidence/data exists that gave rise to and supports this inclusion. We respectfully request that it be removed as soon as practicable from the Mental Health Bill 2024.”” arsa an t-alt seo faoi

To be frank and blunt this is unsatisfactory. The transcripts of my 2ND CLASS HONOURS GRADE 1 show that I was awarded a degree much better than a bare pass, but Dublin-City University continues to refuse to help me show that it is

much better than a bare pass (by for example by expressing "2ND CLASS HONOURS GRADE 1" as a percentage range) therefore I received not even a single cent of a Portuguese scholarship which I should had begun receiving during 2009.

This is a precedent of Irish documents which are not in plain English being rejected in Portugal by people who may believe what I claim but they do not want to admit that what the documents and I claim to be true is true, because needing to pay someone money would result from a fair admission.

Jim Lucey and I agreed that I would be assessed at Saint Patrick's University Hospital for the express purpose of getting monies which are still owed to me from the Republic of Portugal for my research career. Saint Patrick's University Hospital has failed to honour this duty which it was entrusted to do. Instead, the first attempt to renounce this obligation was made by Professor Paul Fearon on 22/05/2013 - very long after I met Dr. Jim Lucey. I do not wish to cause insult: nonetheless I accurately document a lack of integrity of Saint Patrick's University Hospital.
