## **Combating racism in Portugal:**

#### an analysis of public policies and anti-discrimination law

I hereby apply for the aforementioned research fellowship. Please find enclosed a curriculum vitae which confirms that I have experience from many other nations. Alas, I must relate that — unlike each of the many foreign countries where I had worked and/or studied and/or visited — I have been suffering from life-threatening, racist xenophobia in Portugal since 2008. Perpetrators of very significant proportions of this abuse are the Portuguese Foundation for Science and Technology (that is funding this fellowship (at my expense with money reserved for earlier fellowships of mine which the Portuguese Foundation for Science and Technology illegally, racistly, xenophobically, unfairly refuses to pay to me)) and the University of Coimbra. Please find enclosed documentation re a strict subset of examples of racist discrimination by the Portuguese Foundation for Science and Technology to me Portuguese Foundation for Science and Technology the Portuguese Foundation for Science and Technology against my minority nationality.

Racism is rife amongst powerful entities in Coimbra; near Coimbra; and amongst fraudful actors elsewhere in Portugal of what passes for science. It is at least some relief to state that, in my experience, <u>a lot of persons in Portugal are not xenophobic</u>. Not merely are they not xenophobic, they pity me and they attempt to help (e.g. by donating food, even though I do not beg) — whether or not they are acquainted with me, they can often see that I am in poverty. I had never needed to receive such charity before I have been cheated of tens of thousands of Euro in Portugal. I had assisted a number of anti-racist charities<sup>3</sup> outside of Portugal, but I had never been on the receiving end of charity before I have been

extensively victimized in Portugal. I would rather not be on the receiving end of charity, but it has given me a perspective of the niceness of conscientiousness which I would not otherwise have.

My poverty led onto residing without running water therefore I could not drink tap water and I could not use a toilet and I could not bathe and I could not shower. Kind persons were concerned that I was reduced to these (and worse) living conditions, therefore a town hall in Condeixa provides me with temporary, emergency accommodation. However, in so doing, I deprive a family with children of such accommodation. This does not make me feel at ease. If communication by email would be necessary, please contact me c/o Catarina.Pereira@CM-Condeixa.Pt. I do not reside in Condeixa. I am a guest in Condeixa and I might not continue to be a guest in Condeixa by the time you shall decide to whom to award this research fellowship. I continue to use a stable address in Coimbra for snail mail.

During racist harassment against me by Guards of the National Republic in Condeixa, a Guard of the National Republic explained to me: "If you were Portuguese, you'd be home by now." During racist harassment against me by Sandra Roxo of the Judiciary Police in Coimbra, she falsely professed that I am supposedly mentally ill. I am not ill: I am an autist. There is a big difference: being an autist is being a member of a minority, genetic race. Public-Security Policemen in Coimbra acted against me on behalf of the University of Coimbra by violating one court order during 2014 and another court order during 2016. In other countries policemen uphold laws instead of breaking them. Other Guards of the National Republic and other Public-Security-Police officers (including even some in Coimbra) were nice to me. E.g. an unsuccessful attempt had been made to steal off me at a train station near an airport. I reported this to the local Public-Security Police that escorted me to a railway platform to prevent another could-have-been-attempted theft.

I also heard of racistly xenophobic abuse by a police officer in Portugal against a migrant friend who resided in Portugal since before I moved to Portugal — telling him to return to his country without even knowing what his nationality is<sup>4</sup>. There is a lot of denial in Portugal that racism is rife amongst powerful entities in Portugal. An example involving a scientific fraudster who abused me since the previous decade is this discussion that occurred on August 4<sup>th</sup>, 2014 —

Maria Filomena<sup>5</sup> de Osório Pinto dos Santos Figueiredo: This is not your country. Go to your country. [. . .]

Nicholas Collin Paul de Gloucester: I can do without racist discrimination.

Maria Filomena de Osório Pinto dos Santos Figueiredo: Sorry?

Nicholas Collin Paul de Gloucester: I can do without racist discrimination.

Maria Filomena de Osório Pinto dos Santos Figueiredo: This is not, this is not racist discrimination.

[...]

Connivance or even indifference to evil is a problem amongst bodies in Portugal that are

entrusted to combating what they allow to continue to be perpetrated. E.g. as I was illegally not being paid for a long time for scientific research in Coimbra, I needed money to buy food therefore I applied to a company<sup>6</sup> in Lisbon for vacancies that it advertised. The only language of these then vacancies is a foreign language that I do not speak as a language of my nationality but which I do speak better than persons who studied it in Portugal. Even this company underperformed at this language as evidenced by a job advertisement by this company. This firm rudely ignored me, therefore I complained to Maria Isabel Lima of the Autoridade para as Condições do Trabalho (ACT) who assisted Teleperformance to cover up its illegally racist discrimination.

I am an Asperger autist therefore I whistleblew because of my conscientiousness as explained by Attwood, Tony, 2008, *The Complete Guide to Asperger's Syndrome*, London, UK: Jessica Kingsley Publishers on Page 118:

"Adults with Asperger's syndrome can be renowned for being honest, having a strong sense of social justice and keeping to the rules. They strongly believe in moral and ethical principles. These are admirable qualities in life but can cause considerable problems when the person's employer does not share the same ideals. I suspect that many `whistle-blowers' have Asperger's syndrome. I have certainly met several who have applied a company's or government department's code of conduct to their work and reported wrongdoing and corruption. They have subsequently been astounded that the organizational culture, line managers and colleagues have been less than supportive; [...]"

That I am an autist is public knowledge but the supervisrix Professrix Maria Filomena de Osório Pinto dos Santos Figueiredo dishonestly professed contrarily on August 4<sup>th</sup>, 2014 —

Maria Filomena de Osório Pinto dos Santos Figueiredo: you've been institutionalized because you were ill so [...]

Nicholas Collin Paul de Gloucester: I was not ill. Doctors proved

Maria Filomena de Osório Pinto dos Santos Figueiredo: Okay.

Nicholas Collin Paul de Gloucefter: that I was healthy.

[...]

Nicholas Collin Paul de Gloucefter: Rui

Maria Filomena de Osório Pinto dos Santos Figueiredo: Okay.

Nicholas Collin Paul de Gloucester: Ferreira

Maria Filomena de Osório Pinto dos Santos Figueiredo: Okay.

Nicholas Collin Paul de Gloucester: Marques

Maria Filomena de Osório Pinto dos Santos Figueiredo: Go. Go.

Nicholas Collin Paul de Gloucester: and Rui Miguel

Maria Filomena de Osório Pinto dos Santos Figueiredo: Okay.

Nicholas Collin Paul de Gloucefter: Curado da Silva;

Maria Filomena de Osório Pinto dos Santos Figueiredo: Goodbye.

Nicholas Collin Paul de Gloucester: Paulo Jorge Ribeiro da Fonte; and LIP

Maria Filomena de Osório Pinto dos Santos Figueiredo: Okay.

Nicholas Collin Paul de Gloucester: lied about me.

Corruption is rife in Portugal, so much so that a Portuguese word (*cunha*) can be concisely translated into neither English nor Swedish. No legitimate reason could be found to expel me after I whistleblew, because I am a well behaved elite scientist who paid the putative University of Coimbra thousands of Euro which it promised I would not be charged and who is owed much more than extortionate sums that I paid. Therefore during late 2012 or during January 2013 the supervisor Rui Michael Curado da Silva and the two co-directors<sup>7</sup> of the Coimbra section of the host institution<sup>8</sup> fabricated false concerns about my mental health. The supervisrix boasted during 2013 that I was locked up in a nuthouse. The putative Hospital of the putative University of Coimbra was an accomplice to this institutional racism by, inter alia, falsely professing that a brain scan supposedly detected permanent physical damage to my brain. As a matter of fact, a brain scan showed no physical damage to my brain. The putative Hospital of the putative University of Coimbra perpetrated perjury against me to a criminal tribunal, thereby successfully obtaining immunity from prosecution to perpetrate aggravated assaults against me which it proceeded to perpetrate<sup>9</sup>. It emitted malicious falsehood to a visitor who truthfully said "You're lying." The criminal judges<sup>10</sup> Vera Cristina<sup>11</sup> da Silva Gomes de Oliveira and Sara<sup>12</sup> André dos Reis<sup>13</sup> Margues also maliciously professed falsehood against me. Nuno Gonçalo Gomes Fernandes Madeira of the putative Hospital of the putative University of Coimbra lied to me by promising that the staff of the putative Hospital of the putative University of Coimbra would stop beating me up if I would sign a document that he gave me. Of course I signed it: but they continued to beat me up.

I am not the only elite migrant scientist who was wrongfully locked up and physically put at risk in a putatively psychiatric section of the putative Hospital of the putative University of Coimbra after being "intellectually raped"<sup>14</sup> after being lured to Portugal by an unfilled promise by the fraudulently named organization which calls itself the University of Coimbra. One such victim of Coimbra "University" and of the "Hospital" of the "University" of Coimbra described acceptance of an offer by Coimbra "University" as the most significant mistake of that scientist's life.

After dishonesty by Nuno Gonçalo Gomes Fernandes Madeira, I met real psychiatrists instead of quacks. They proved my lack of mental illness, but the supervisor Rui Michael Curado da Silva maliciously persists with this fabrication. E.g. on May 18<sup>th</sup>, 2016 Rui Michael Curado da Silva dishonestly perpetrated defamation against me—

Nicholas Collin Paul de Gloucefter: I

Rui Michael Curado da Silva: You know it very well.

Nicholas Collin Paul de Gloucester: I am not mentally ill. You lied

Rui Michael Curado da Silva: Yes you are.

Nicholas Collin Paul de Gloucefter: you lied about me to get it seem to be that I was mentally ill. I am not mentally ill. Numerous psychiatrists proved this.

The Portuguese Foundation for Science and Technology racistly deprived me of a doctoral scholarship since 2008. Cf. e.g. inter alia my complaint to the Ordem dos Advogados against Paul Ricardo<sup>15</sup> Novais Vilas Boas<sup>16</sup>. Paul Alexander Cunha<sup>17</sup> Gomes<sup>18</sup> assisted the Portuguese Foundation for Science and Technology with racist bullying during 2011. I attempted to sue him during 2012 but he and Professor Joaquim Marques Ferreira dos Santos dishonestly gave false testimonies on his behalf. The public-prosecution service of Portugal knew that they gave false testimonies but the public-prosecution service of Portugal decided to use this false testimony of Professor Joaquim Marques Ferreira dos Santos in its rationale to not sue Paul Alexander Cunha Gomes! The public-prosecution service of Portugal professed that it would not be possible to get a conviction for perjury in this matter because false testimony by Paul Alexander Cunha Gomes was given to a police officer instead of to a judge. Outside of Portugal it is possible to be convicted for perjury even for false testimony that is not given to a judge.

Disrespect for my nationality is common in Portugal. For example, when I testified against Paul Alexander Cunha Gomes, the Public-Security Police of Coimbra lied about my nationality. I insisted on my nationality being recorded correctly, but the Public-Security Police of Coimbra refused to do so for this process. (This so-called nationality professed by the Public-Security Police in Coimbra is not even a real nationality.) For years the putative University of Coimbra insultingly had an untrue real nationality on official documentation about me despite protests by me. However, it made sure to report that I am Irish when perpetrating defamation against me to a journalist during August 2014 and it made sure to not report that it is acting against me because of my race. A different unreal nationality was professed in tribunals; by Guards of the National Republic in Condeixa; and on my residence card.

The Ordem dos Advogados; the University of Coimbra; a jurist thereof named Pedro Henriques; and the lawyer Carlos Felício da Costa illegally use my race against me to deprive me of a doctoral examination.

I performed a lot of archive research. I reviewed a lot of the scientific literature. Most of this was on my own initiative via my autonomy.

To defend itself in court, the Portuguese Foundation for Science and Technology was

unable to rely on a webpage by me to justify not paying a PhD scholarship, therefore it submitted a manipulated (doctored) distortion of a webpage to a court.

LaTeX is typesetting software utilized by scientists including physicists and computer scientists. It is useful for managing bibliographic citations, especially when used with additional software called Biber or BibTeX. It is not predominantly utilized for law journals, though files to make it support German; UK; and US legal styles exist. US support was programmed by Christopher de Coro. He calls this software LawTeX<sup>19</sup>. Unfortunately, LawTeX is incompatible with both Biber and BibTeX. Therefore I created software which converts from Biber/BibTeX format to LawTeX format.

The Machiavellian Portuguese Foundation for Science and Technology obstructs research into xenophobic racism by obscuring its xenophobia. E.g. contrast illegal (initial) rejections of more than 400 researchers of foreign nationalities with a misleading press release<sup>20</sup> that was designed to make it seem that financial difficulties instead of illegal, deliberate rejections merely delayed payments to us.
