## 1.1 The beginning of this cover letter

1<sup>st</sup> to 8<sup>th</sup>; and 10<sup>th</sup> to 12<sup>th</sup>; and 15<sup>th</sup> to 19<sup>th</sup> September 2025

Dear Doctoress Alice Jill Edwards et al.,

Murders are consequences of perpetrations of systematic widespread torture by Portugal. Cf. reports by the CPT – <HTTPS://WWW.COE.int/en/web/cpt/portugal> – and SPT about less evil misadventures. Cf. The United Nations’ Subcommittee on Prevention of Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment of the Committee against Torture. CAT/OP/PRT/1 Visit to Portugal undertaken from 1 to 10 May 2018: observations and recommendations addressed to the State party Report of the Subcommittee. The World: United Nations, 3<sup>rd</sup> July 2019. <HTTPS://documents.UN.org/doc/undoc/gen/g19/198/71/pdf/g1919871.pdf?token=c6dW0jCFrAVhBZ3Ghy&fe=true>

Professor Nils Melzer wrote AL PRT 1/2021 (for victims in Syria of Portuguese nationality) to Portugal. He also wrote apparently “similar” AL GBR 2/2021; AL SWE 1/2021; AL DEU 3/2021; AL FRA 6/2020; and AL BEL 1/2021 for victims in Syria of nationalities of the United Kingdom of Great Britain and Northern Ireland; Sweden; Germany; France; and Belgium. He also wrote apparently “similar” AL CHE 1/2021; AL ESP 1/2021; AL NLD 1/2021; AL AUT 1/2021; AL RUS 1/2021; AL CHN 1/2021; AL AUS 1/2021; and AL USA 8/2021 for victims in Syria of Swiss; Spanish; Dutch; Austrian; Russian; Chinese; Australian; and USA nationalities.<sup>1</sup> All my processes in these fourteen countries are related to systematic torture perpetrated against e.g. me during 2013 by Portugal. I explicitly refer to torture in such processes in Portugal; the UK; Sweden; Germany; France; and Belgium.

The UK explicitly lies that it lacks universal jurisdiction and that it is not a State Party to the International Criminal Court. The UK also refuses to prosecute accomplices in the UK (i.e. even when an international instance is not required).

Portugal insists on writing to me in Portuguese but I cannot comprehend Portuguese and it wrote to Prof. Melzer in English. I wrote 2019-10-09\_Strafanzeige against torture. Guards at Portugal seem to purport that torture is NOT A CRIME: cf. 2024-03-01a\_email\_from\_GNR\_from\_Coimbra\_in\_Portuguese.txt

I continue to wait for progress from all these countries. I complain to all these countries (except Sweden and Switzerland) and the putative Republic of Ireland (which has universal jurisdiction and is a State Party to the ICC) since before 2019. I complain to Sweden since 2022. The putative Republic of Ireland promises me an action since years ago but it forces me to wait: maybe dishonestly forever.

Please contrast these nations’ lacks of progress with these words by Prof. Melzer in AL PRT 1/2021: “Governments also have a duty to protect the absolute prohibition of torture and of refoulement.

There is an urgent need for justice, truth and reparation for all of the victims of the very serious violations of human rights and humanitarian law that have occurred in the region. States that can deliver justice in accordance with international human rights law therefore have a responsibility to

prosecute individuals against whom there is sufficient evidence of criminal behaviour, and sanction them appropriately through fair trials that comply with due process.

[. . .]

It is also inherent in a State's obligation to take positive preventive operational measures to protect the right to life.[Footnote]<sup>34</sup> namely that a State may exercise control over a person's rights by carrying out activities which impact them in a direct and reasonably foreseeable manner, meaning that a State's responsibility to protect may thus be invoked extra-territorially in circumstances where that particular State has the capacity to protect the right to life against an immediate or foreseeable threat to life.

[. . .]

[. . .] As these 'camps' now appear to function as detention and security facilities for over an approximate 10,000 women and children, including your nationals, your legal obligations as a result of the continued detention of your nationals are more significant.

[. . .]

As per the conditions of the detention in the camps, we would like to draw the attention of your Excellency's Government to paragraph 27 of General Assembly Resolution 68/156, [. . .] Holding persons incommunicado violates their right to be brought before a court under article 9 (3) of the Covenant and to challenge the lawfulness of their detention before a court under article 9 (4) of the Covenant. [. . .]

[. . .]

The right to fair criminal proceedings is safeguarded by article 10 of the UDHR article 14 of the ICCPR In particular, we wish to highlight that equality before the law and the principle of equality of arms are key requirements of a fair trial, in criminal and civil proceedings.[Footnote]<sup>61</sup> This demands that resort to 'secret' evidence, intelligence information and information collected, preserved and shared by the military to be used as evidence be strictly limited, and outright excluded when it does not allow the defendant to be in a position to defend themselves effectively, in full respect of this principle." Footnote 32 thereof says: "article 15 of the CAT and included in article 3 of the ECHR: judicial and administrative authorities of states parties are prevented from invoking information extracted by torture in any proceedings". Footnote 44 thereof says: "*The Special Rapporteur wishes to emphasize the important role that effective consular assistance plays as a preventive tool when faced with a risk of flagrant violations or abuses of human rights, while also noting that the remedial nature of diplomatic protection proceedings*". Torture was perpetrated against me by Portugal because our embassy to Portugal refuses to oppose discrimination against us since years before torture. I accuse to e.g. the Language Commissioner – [HTTPS://WWW.COIMISINEIR.IE/TEAGMHALA?lang=EN](https://www.coimisineir.ie/teagmhala?lang=EN) – that this embassy e.g. lies. The staff of the Language Commissioner upholds complaints by me. Cf. e.g. Complaint C020/2025. Our embassies never attempt to sue me (via e.g. a malicious-falsehood law), so I truthfully accuse them.

An earlier UN special rapporteur on torture (John E. Méndez) wrote OL PRT 1/2015: “Mr. Britel was eventually taken by car back to Témara prison. He was accused of engaging in subversive activities. He was again threatened and subjected to torture and forced to sign a confession that he was never permitted to read.

[. . .]

An observer from the Italian Embassy reported that the trial failed to comply with due process and fair trial standards and that the procedures followed were fundamentally flawed.

[. . .] He was denied access to a lawyer [. . .] continually subjected to violence and humiliation. Guards would often enter his cell, [. . .] take his property, and taunt him [. . .] On one occasion, he was stripped of his clothes and left naked.

While imprisoned, Mr. Britel was visited by Italian diplomatic and consular officials, [. . .]

[. . .] concern is expressed at the above allegations, particularly in connection with the reported lack of investigation, prosecution and criminal accountability of the alleged perpetrators, including Government’s officials who may have devised, planned and authorised such events.

[. . .]

Where a plausible allegation is made that public officials have committed (or been complicit in the commission of) gross or systemic human rights violations, the executive authorities of the State(s) concerned are obliged to carry out *proprio motu* an effective official investigation which is begun promptly, secures all relevant evidence, and is capable of leading to the identification and, where appropriate, the punishment of the perpetrator(s) and those on whose authority the violations were committed.”

I indicate an astonishing big number of countries. I was only physically tortured in Portugal and Ireland (during 2013). Since 2014, libels and malicious falsehoods at most of these places obscure this torture. Judges refuse to issue arrest warrants against torturers (who include fellow judges at Portugal). E.g. “What should I have done?” said I myself as a litigant in person at the England-and-Wales High Court. “I refuse to answer that!” said ‘Justice’ Spencer (who is related to accomplice to murdering an Irish Gaelic speaker) during 2017. Possible exceptions are Luxembourg and Sweden; and Poland and Israel. Luxembourg and Sweden are “otherwise related” because emails of mine there about torture and other crimes against me are destroyed. Also a website and other files at Luxembourg by me about inter alia torture are destroyed. Poland and Israel are relevant because murderers who perjure about torture migrated to them.

## 1.2 This online form has small text fields so pieces which did not fit are here

**Has the Government taken action to prevent or investigate the incident, punish the perpetrators, or ensure compensation to the alleged victim(s)? and If the alleged victim(s) died in custody, was an autopsy or forensic examination performed and which were the results?**

One of those sections is at a generic part of this form and a different one of those sections is at a part about torture. They are similar.

I myself wrote: "I did not die yet, but a different victim was murdered and tortured because of torture against me. Another victim was also murdered and tortured. Yet another victim was murdered in a torture chamber. Many others also died in custody in torture chambers, but I do not know whether or not they are murders. These dishonest secretive torturers systematically perpetrate behind closed doors. Their putatively legal system connives. So probably many more torture victims there are also murdered.

Polices at Ireland; England; and France refuse to investigate. E.g. Sergeant Anthony Malone assaulted me in front of CCTV on 13/09/2025. Cf. Ferriter, "Occasions of Sin: Sex and Society in Modern Ireland"; Yorkshire-Ripper Victim Tracy Browne criticises dismissive police officers via "The Ripper" at Season 1 Episode 4 at 10:10 on Netflix, and criticisms by Sarbjit Athwal and Ex-policeman Clive Driscoll via "When Missing Turns to Murder"'s 2nd season's 6th episode on Netflix; and by Ex-detective Chief Superintendent Bernard Kinsella at "Monique Olivier: Accessory to Murder" at Episode 3 at 25:20 on Netflix.

Polices; courts employees; the Public Prosecution Service; putative legal-aid advocates; witnesses; journalists; and politicians at Portugal perpetrate widespread systematic connivances. Cf. a complaint by myself to José António Pires Baptista of Portugal's Public Prosecution Service

Police officers at Portugal perpetrate successfully subornation of perjury. Cf. Process Number 123/14.9PFCBR (Tribunal Judicial da Comarca de Coimbra, Juízo Central Criminal de Coimbra – Juiz 2) at Page 247 where Policewomen Manuela Pereira and Sandra Roxo lie to Witness Doctor Sharif Hasan Mahmoud Ghithan that his testimonies for a new show trial are for a reason which is incompatible with a real reason. I.e. the real reasons for a new show trial include to obscure torture by an old show trial (Process Number 373/13.5TBCBR, 3º Juízo Criminal de Coimbra).

I do not comprehend Portuguese. Cf. Louise Ryan, Gráinne McPolin, and Neha Doshi, “Irish Nurses in the NHS: An Oral History”, Four Courts Press at Page 163: “I didn’t quite understand.”

I myself (i.e. sans lawyer sans interpreter sans dictionary) wrote a criminal complaint about 2 murders in custody and torture as registered mail in English and German (and quoting exact crimes’ names in Portuguese from a criminal code) namings 2 victims (viz. Jorge Albano Esteves da Silva Fernandes and Hugo Alves) in 2009: “Jorge Albano Esteves da Silva Fernandes – damals Inhaftierungsnummer 415 – ist zu einem Beispiel[e] gestorben.[...]Hugo Alves – damals Inhaftierungsnummer 293 – ist zu einem Beispiel[e] gestorben. Kein Gericht erklärt, dass er schuldig sei.[...]Cf. Artigos[...]; 131.º Homicídio; 132.º Homicídio qualificado; 135.º Incitamento ou ajuda ao suicídio; 137.º Homicídio por negligência;[...]243.º Tortura e outros tratamentos cruéis, degradantes ou desumanos graves;”.

I wrote this criminal complaint by registered mail in 2019 but it became responded to in 2024 only! A response in Portuguese is by 2 police officers apparently refusings to investigate because they pretend that murders and torture are not a crime! “A solicitação formulada por V.<sup>a</sup> Ex.<sup>a</sup> mereceu a melhor atenção por parte deste Comando, cabendo informar que a carta de V. Exa. endereçada ao Posto Territorial de Taveiro, de Outubro de 2019 foi enviada ao Estabelecimento Prisional de Santa Cruz do Bispo – Clínica Psiquiátrica e Saúde Mental, sita na Rua de São Brás, Apartado 5, 4455-848 Matosinhos, para os fins tidos por convenientes e por não se vislumbrar qualquer tipo de crime.” These police officers are named **David Melo da Silva Alferes (Comandante do Destacamento Territorial de Coimbra, em Suplência)** and “Redator: RP”.

Police Sergeant Anthony Malone refuses to investigate so he assaulted me when I brought complaints in front of a CCTV camera at a police station on 13/09/2025. So he delayed this submission to UN special rapporteurs by days. You can download more informations about this misadventure from

I request the author thereof and a solicitor therefor to swear related would-be affidavits about torture. Cf.

2025-06-17a\_affidavit\_model\_to\_solicitor\_in\_Mental\_Health\_Commission.odt

These would-be affidavits would be against police officers who refuse to investigate. This author and this solicitor refuse to swear an affidavit. So alas I say that they and these police officers are guilty of torture via Article 1 of Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment (UN 1984). Cf. I hereby add remarks about Belgium. I do not elaborate on Belgium elsewhere on this form because this form has small fields and timewasters waste my time and the main nations concerning these problems are the 2<sup>nd</sup> Republic of Portugal and the putative Republic of Ireland. Belgium ***is also relevant***.

I became tortured during 2013 as a consequence of misadventures during 2005 when I used to be a slave of the European Space Agency. As I am an ex-employee of the European Space Agency and Portugal lacks space-science competences, it perpetrated human trafficking via this email of 31/08/2007:

Subject: PhD

“Hi Colin!

My colleague Juan Cabrera told me that you were looking for a PhD project here in Louvain.

Soon I'll lunch [launch] a PhD offer with grant for a gamma-ray focal plane detector development in the framework of the Gamma-Ray Imager space telescope (<http://gri.rm.iasf.cnr.it/>). But this grant is financed by a project of the portuguese [sic] Ministry of Science. I spend half of my research time in the University of Coimbra, Portugal (<http://www.uc.pt/>). So this grant will be supervised by me in Coimbra with the possibility that the PhD student may spend some weeks per year in Louvain as well.

The candidate to this grant must have knowledge in C++ programming and interaction of radiation (gamma-rays and X-rays) with matter. Its work will be essentially developing a GEANT4 based simulation code (<http://geant4.web.cern.ch/geant4/>) for the telescope focal plane detector.

I took a look to your CV and it matches partially with the profile I'm looking for. If you have some knowledge about interaction of radiation with matter it should be fine.

If you still didn't found [find] a PhD thesis[dissertation], feel free to pose me some questions in case you are interested. Otherwise, you are also free to send this information to eventual friends or colleagues that might be interested.

He wrote “I spend half of my research time in the University of Coimbra, Portugal” but I estimate that from 2008 to 2014 he used to spend circa 75% of his time in Belgium, though during those years he used to be officially (on paper) domiciled at Portugal. (His wife works at and is domiciled at Belgium.)

After he tortured me I do complain to Belgium but Belgium does not convince me that it investigates.

Belgium’s embassy at Portugal explicitly wrote on 14/11/2017 that it does not care: (in Flemish:)

I faxed a complaint against this torturer to many Belgian-police stations. I wrote that complaint in (probably broken) Dutch and German. I am not proficient at French. Only one Belgian-police station contacted me. It insists on using French. It seems to not investigate because it stopped answering many years ago and this torturer escaped from Belgium (and later returned to Belgium taking up a new Belgian job).

Judges signed a court order granting immunities from prosecutions to torture me. Cf. Process Number 373/13.5TBCBR, 3º Juízo Criminal de Coimbra, signed by court judge Sara André dos Reis Marques and district attorney Vera Cristina da Silva Gomes de Oliveira. Portugal’s motivation to torture me is to censor whistleblowing by me against a rich ex-employer (to access its “Property status”) which we apply to for €230 million after it enslaved me during 2005 and used to persecute me during 2005. So Portugal perpetrates sycophancy against “Engagement in human rights, trade union, political, religious activities or other types of activities”; “Political or other opinion or beliefs”; “Religious background”; “Race”; “Belonging to a specific group”; and “Other status, affiliation or background” by me. (I reckon Asperger autists to be in a different race than neurotypicals.) Since 2014, libels and malicious falsehoods at most of these places obscure this torture. Judges refuse to issue arrest warrants against torturers (who include fellow judges at Portugal). E.g. “What should I have done?” said I myself as a litigant in person at the England-and-Wales High Court. “I refuse to answer that!” said ‘Justice’ Spencer (who is related to an accomplice to murdering an Irish Gaelic speaker) during 2017. Possible exceptions are Luxembourg and Sweden; and Poland and Israel. Luxembourg and Sweden are “otherwise related” because emails of mine there about torture and other crimes against me are destroyed. Also a website and other files at Luxembourg by me about inter alia torture are destroyed. Poland and Israel are relevant because murderers who perjure about torture migrated to them.

I complain to the Office of the Police Ombudsman Fiosrú. A police officer and Fiosrú belittle murders and inter alia torture. This Police-Ombudsman Office refuses to investigate. “Why are you reporting it [i.e. 3 murders despite her using a singular pronoun] here?” said this police officer on

28<sup>th</sup> November 2024! A friend said that you report murders to a police station! Cf. We migrant scientists are victims of human trafficking perpetrated in connections to SLAVERY; exterminations; persecution; discrimination; subventions frauds; and defamations, which caused murders and torture. So I was tortured so the European Committee for the Prevention of Torture visited me at torture chambers and it repeatedly criticises Portugal over violating international law against me.

The University of Coimbra lied to me on 31/08/2007: “Hi Colin!

...Soon I'll lunch[launch] a PhD offer with grant for a gamma-ray focal plane detector development in the framework of the Gamma-Ray Imager space telescope...financed by a project of the portuguese Ministry of Science...I took a look to your CV and it matches partially with the profile I'm looking for...it should be fine.

If you still didn't found[find] a PhD thesis, feel free to pose me some questions in case you are interested.” It advertised in bad faith an inexistent 3-year scholarship starting in October 2007 but instead it is a non-scholarship salary started in June 2008. This university told me for the 1<sup>st</sup> time on 14/12/2009 that it would end in September 2010. I had no salary in 2011; January 2012; and since 2013.

SLAVERY and human trafficking are important essential background elements which caused torture (against me) which caused murders against different torture victims (but I am not murdered yet).

We migrant scientists are victims of slavery via dishonest international recruiters. These recruiters include the European Space Agency; ADDF (Associação para o Desenvolvimento do Departamento de Física) (“nº de identificação de pessoa colectiva 505 040 557”) (at the University of Coimbra but officially it is not a part of a university); the putative University of Coimbra; LIP - Laboratório de Instrumentação e Física Experimental de Partículas; and the Portuguese Foundation for Science and Technology.

2 of us had been ordered to perform paid works in February 2005, but long after we arrived and worked these employers have dared to dishonestly say that they had not offered to pay us salaries for February. In March, an employer created; typed; printed; and signed contracts requesting us to countersign and return them *BY FEBRUARY I.E. TO SEND THEM BACKWARDS THROUGH TIME!* So such an employer coerced us to work for gratis as slaves in February. Cf.

I wrote to a court: “on 16/09/2004 a human-trafficking criminal who used to enslave us in 2005 said: “We have paid internships”. E.g. on 29/10/2004 an accomplice human-trafficking criminal who used to enslave us in 2005 (and who seems to have lied about this in 2012 or 2013 according to a disclosure by the Portuguese Foundation for Science and Technology in 2014) said: “We are happy to offer you an internship for a minimum of 3 months, starting in principle from Jan. 2005. We have requested an internship position for you...(including 600 euro/month funding). If this fails, we will offer you a position...according to the Leonardo da Vinci scheme (440 euro per month + transport 2x100 euro). As regards judges, even in the absence of an explicit allegation of ill-treatment, they should request a forensic medical examination whenever there are other grounds to believe that a person brought before them could have been the victim of ill-treatment.” says [HTTPS://Rm.COE.int/1680adcb76](https://rm.coe.int/1680adcb76) by the CPT.

“By means of example, the CPT wishes to highlight the following four cases of alleged ill-treatment.

i. A man met by the delegation in the Judicial Police Prison in Lisbon on 25 May 2022 alleged that, on the evening of 1 April 2022, he was punched in the face by two officers from a GNR station in Sintra, after he had refused to allow his car to be searched and asked for a lawyer. He stated that he had received these punches before and after he had been

handcuffed behind his back and that later that evening, he was assaulted again at the Sintra GNR station, after he had repeated his request for a lawyer. Allegedly, during the assault both his knees were injured, and police officers took him to the Dr Jose de Almeida Hospital in Cascais. Apparently, at the hospital the accompanying police officers threatened him with more beatings if he were to reveal that he had been punched by the police. In the arrest report, consulted by the delegation, it is noted that “No incidents were registered during the arrest”. However, this is contradicted by other documentation seen by the delegation in the records of his custody that state he was taken to hospital, [. . .]

ii. A man met by the delegation on 25 May 2022 at Lisbon Central Prison alleged that on 28 April 2022 at approximately 21:00 he was punched in both eyes by PSP police officers when already handcuffed. Apparently, the punches caused pain to the extent that he could not open his eyes for some time. Upon arrival at the PSP 4th district station (“Palacio de Folgosa”) he claimed to have received punches once again when expressing his wish to press charges concerning the ill-treatment to which he claimed to have been subjected earlier. Apparently, he was not offered medical attention” says [HTTPS://Rm.COE.int/1680adcb76](https://rm.coe.int/1680adcb76) by the CPT.

The persons who manhandled me during torture to inject a torture drug into me during 2013 are putatively psychiatric putative nurses at a so-called hospital of a State-owned putative university. They did so because of an order by a putative psychiatrist. I am never informed of what he is called. He ordered so because court judge Sara André dos Reis Marques and district attorney Vera Cristina da Silva Gomes de Oliveira illegally grant them immunities from prosecutions. Cf. Process Number 373/13.5TBCBR, 3º Juízo Criminal de Coimbra. This court grants this court order because of a petition signed by various employees from this putatively psychiatric so-called hospital including Putative Psychiatrist Nuno Gonçalo Gomes Fernandes Madeira.

I am a scientific whistleblower against an evil ex-employer, namely Philippe Willekens of the European Space Agency to which we apply for 230 million Euro for my Portuguese PhD project, after he perpetrated humans trafficking and slavery and extermination against us (i.e. migrants then masters' students), and also persecution and discrimination and subventions frauds, so he later caused torture against me and against a friend, and he murdered this friend. So as to support sycophancy to Ex-employer Philippe Willekens and the European Space Agency so as to access subventions of €230 million, these torturers contradict psychiatrists by pretendings "long-standing non-bizarre delusions involving academic and scientific organizations" but they fail to show any plausible evidence that I ever believe anything which is false to supposedly be true. N.B. such torturers significantly falsified putative translations of what I really wrote when they desperately maliciously incited 2 criminal judges to order a compulsive commitment against my brain to discredit whistleblowing. A judge thereof wrote that she does not understand our language, but she never uses an interpreter for me! These torturers refuse to use truths and proofs of truths and honesty and a logic and disproofs against what I believe, so they fail to convince me fairly to confess for a rich funding agency that I purportedly believe falsehoods "involving academic and scientific organizations", so they tortured me at a putatively psychiatric putative hospital by a compulsive-commitment criminal-court order without ever appearing at this court and without an interpreter without a lawyer without informing me of who the witnesses are and what they allege and without ever specifying to me the particulars of claim! They forcefully injected me with the drug that hurt my legs even months after the last injection! Its patients' information leaflets and the scientific literature confirm that it tortures.

I will sue you!” are the last 2 (repeated) sentences that I said to torturers while 5 torturers held me moments before they made me bleed. No lawyer ever represents me on the process that ordered detention and torture against me during 2013. These torture chambers obstructed my money so I was not able to spend it to pay lawyers to defend me (but my Portuguese bank account had more than enough money to pay lawyers, so I paid lawyers after I escaped and we prevail with a consequential court case). A torturer lied to me sans lawyer sans interpreter when he pretended to translate a document for me. He promised me that that document means that if I would sign it then they would stop torturing me. I am too trusting (i.e. not paranoid) so I signed it. Instead it is a false confession so they did not stop torturing me for months! “That false confession deprived me of a lawyer[Footnote]<sup>19</sup>[Conniver Ana Carolina Simões Rodrigues Silva] and a hearing, thereby violating a law which the European Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment reports:”

That night, at 00:20, he was transferred to the Metropolitan PSP[Public-Security-Police] Headquarters station at Moscavide Avenue, Lisbon. In the intake report, as concerns physical injuries, it states “Nothing to report”. At 9:00 that day he appeared before a judge, in the presence of a [court appointed lawyer. Despite displaying visible injuries and explaining their origin to his lawyer, neither the judge nor the lawyer took any action](#). Subsequently, at 00:30 on 30 April 2022 he was transferred to Lisbon Central Prison where, upon arrival, facial bruising was noted and described in an injury report as “bilateral periorbital hematomas”. The facial bruising is visible on the identification photo taken upon admission to Lisbon Central Prison as seen by the CPT but was not specifically photographed as part of the injury report.

The Portuguese authorities have never sought to deny the general existence of the problem of ill-treatment of persons deprived of their liberty [. . .]

[. . .] Several persons interviewed by the delegation said that they had been presented to a judge whilst bearing visible injuries, but that neither the judge nor the designated (*ex officio*) lawyer, inquired about the origin of those injuries. The cases set out under paragraph 14 i and ii lend credence to claims of this nature.

[. . .] Neither *ex officio* lawyers nor judges react proactively when people with visible injuries appear in court. [. . .]

The CPT attaches particular importance to three rights for persons deprived of their liberty by the police:

- the right of those concerned to have the fact of their detention notified to a close relative or third party of their choice;
- the right of access to a lawyer;
- the right of access to a doctor.

Doctoresses and doctors examined me days after I escaped. Particularly from 22<sup>nd</sup> April to 29<sup>th</sup> May 2013 and on 23<sup>rd</sup> September 2013 and on 1 day between 14<sup>th</sup> and 19<sup>th</sup> April 2013.

Portuguese law permits assaulting mentally ill people. After whistleblowing by me against Paolo Donzelli[. . .] and Philippe Willekens of the European Space Agency, Rui Miguel Curado da Silva [. . .] decided to perpetrate sycophancy to Philippe Willekens and Paolo Donzelli and the European Space Agency by alleging false facts to Dr. Graça Santos and Dr. Nuno Gonçalo Gomes Fernandes Madeira of the Hospital of the University of Coimbra. ### 3.21 Was appropriate treatment received for injuries sustained as a result of the torture? [A HTML TextArea tag says "maxlength="4000""]

I did not receive an appropriate treatment. Portugal refuses to pay medical costs. This torture used to inflict *permanent* physical injuries for months during 2013. I live off a disability allowance by Gaelic social welfare as a consequence. Portugal illegally refuses me social security so is guilty of extermination. My supervisrix Professrix **Maria Filomena de Osório Pinto dos Santos Figueiredo** abusively said during 2014: "This is not your country. Go to your country. [. . .] This is not, this is not racist discrimination. [Sic. . . .] If you don't have how to survive here - what are you doing here?" Judges have a microphone recording of this conversation but even these judges perpetrate perjuries about this conversation via a show-trial perverse putative judgment! "That's your problem. That's your problem. That's your problem. I don't care about it. [. . .] That's your problem. Go and find a job" has said she during this conversation without a reference so frustrating applications for a job. Actually that I had applied for jobs and requested references had been used as lame excuses to cancel a PhD scholarship! Catch-22! She and Portugal are unjust. She slandered me about torture during this conversation. She perpetrates perjury about these provocations but these show-trial judges pretend to believe her. "How many, how much of the social security for my first contract was paid?" said I myself during this conversation. I planned to say "our first [Portuguese] contract" which I should have said but in the stressful heat of the moment I said "my". This salary is from the Years 2008 to 2010 and more than 17 years each cent of its social security is never paid! I.e. extermination and subvention fraud and human trafficking. ### **3.23 If the alleged victim(s) died in custody, was an autopsy or forensic examination performed and which were the results? [A HTML TextArea tag says "maxlength="4000""]**

I did not die yet, but a different victim was murdered and tortured because of torture against me. Another victim was also murdered and tortured. Yet another victim was murdered in a torture chamber. Many others also died in custody in torture chambers, but I do not know whether or not they are murders. These dishonest secretive torturers systematically perpetrate behind closed doors. Their putatively legal system connives. So probably many more torture victims there are also murdered.

Police officers at Portugal perpetrate successfully subornation of perjury. Cf. Process Number 123/14.9PFCBR (Tribunal Judicial da Comarca de Coimbra, Juízo Central Criminal de Coimbra – Juiz 2) at Page 247 where Policewomen Manuela Pereira and Sandra Roxo lie to Witness Doctor Sharif Hasan Mahmoud Ghithan that his testimonies for a new show trial are for a reason which is incompatible with a real reason. I.e. the real reasons for a new show trial include to obscure torture by an old show trial (Process Number 373/13.5TBCBR, 3º Juízo Criminal de Coimbra).

I wrote this criminal complaint by registered mail in 2019 but it became responded to in 2024 only! So I was tortured so the European Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment visited me at torture chambers and it repeatedly criticises Portugal over violating international law against me.

HUMAN TRAFFICKING and slavery are important essential background elements which caused torture (against me) which caused murders against different torture victims (but I am not murdered yet). I spent circa 2 weeks writing this online form. (I took a break on 9<sup>th</sup> September 2025 successfully to make the European Parliament act against genocide. Cf.

So I regret that I did not write on this form as many details as this form deserves about human trafficking and violations which are not torture. I am exhausted from sleep deprivation from overwork caused by too few lawyers helping us. So if you would be interested to investigate, then please inform me so I would elaborate and properly answer questions. I am sorry during the meantime!

We migrant scientists are victims of humans traffickings via dishonest international recruiters. We moved from e.g. Ireland; Sweden; Spain; and France to the Netherlands; and from Italy to Portugal then to Ireland then back to Portugal then again to Ireland. These recruiters include the European Space Agency; ADDF (Associação para o Desenvolvimento do Departamento de Física) (“nº de identificação de pessoa colectiva 505 040 557”) (at the University of Coimbra but officially it is not a part of a university); the putative University of Coimbra; LIP - Laboratório de Instrumentação e Física Experimental de Partículas; and the Portuguese Foundation for Science and Technology (Fundação para a Ciência e a Tecnologia, I.P.). Another ex-recruiter which perpetrated humans traffickings against me and against another migrant scientist which caused this torture and a murder used to be Delta-Utec Space Research & Consultancy, but its dishonest ineptness caused it to go out of business (but a human-trafficking enslaver thereof then became employed by the European Space Agency from which he abuses me again, causing human trafficking against me as a slave from Portugal to Ireland and back to Portugal and back to Ireland).

**3.25 The Means (How it is done): Was there threat or use of force/coercion/ abduction/fraud/deception/ abuse of power or vulnerability/ giving payments or benefits to a person in control of the victim? [A HTML TextArea tag says “maxlength=“4000””.]**

I refer to many misadventures of human traffickings against me (and against other victims on occasions). They all involve the European Space Agency which thinks that it is immune from prosecutions because it bribes governments with millions of Euro. Human traffickings against me were perpetrated during 2022 (to Ireland from Portugal); during 2013 (to Ireland from Portugal then back to Portugal); during 2008 (to Portugal from Italy); and during 2005 (trafficking me from Sweden and others from Spain and France to the Netherlands). Also other victims are trafficked during other years to Portugal by the putative University of Coimbra or the Portuguese Foundation for Science and Technology (which is a racist anti-scientific funding agency for the European Space Agency). Cf. Darren O'Brien (from Ireland to Portugal and back) formerly with Research Assistantship Grant CAUP-04/2002-BI formerly supervised by Professrix Maria Teresa V. T. Lago.

We used to be 3 masters' students at Sweden; Spain; and France during Academic Year 2004-2005. The European Space Agency lured us with dreams jobs which we realised too late to be nightmares because of pretenses causings extermination; harassment; bullying; etc. We are victims of frauds and deceptions and abuses of powers and vulnerabilities. One other of us and I are victims of givings payments to persons who used to control us victims.

A subventions fraudster at the University of Coimbra published publications about “Astrophysics” but after he hired me he confessed privately to me that he is *NOT* an astrophysicist. He wants €230 million from the European Space Agency but he is a wannabe space scientist so he perpetrated fraud and deception to human traffick an ex-European-Space-Agency employee (me) from Italy to Portugal so as to have a competent underling to help him to apply to the European Space Agency for prestigious funding, by lying to me about an inexistent PhD scholarship.

Tax-funded scientific organisations do not spend their own monies. Not needings to be worthy of salaries promote inept locals who need to recruit competent underlings: many migrant postgraduate students. So tax-funded scientific organisations do not take care. N.B. I migrated for a space private non-tax company and it never mistreats me (e.g. it never perpetrates human trafficking).

I detected a high risk whilst I am a PhD student that other postgraduate students could become similar humans-traffickings victims of the European Space Agency via frauds and deceptions so I whistleblow to prevent them from sufferings what we used to suffer. Cf.

Go to your country.**” “This is not your country.” said he too on 29/01/2013 too complaining that I “pissed off” this funding agency to which we apply for “a lot of money.” So this sycophancy is for giving payments for persons in control of this victim. So they arranged false imprisonment (abduction) during which uses of forces (torture) were perpetrated against me in 2013 via threats; coercions; frauds; deceptions; and abuses of powers and vulnerabilities. My PhD-scholarship then supervisor and a false-imprisonment torturer sent me on a wild-goose chase in bad faith by ordering me to temporarily go to Ireland before more than 3 quarters of this PhD scholarship would be paid but a losing defendant disobeys a court order to pay me.

It libels my mental health to discredit whistleblowing by myself to incite putatively psychiatric employees to torture me chemically. Cf. E.g. another innocent deported migrant PhD student who was also tortured by [putative "Hospital"](#) Sobral Cid said: "Accepting the offer from the "University" of Coimbra is the worst mistake of my life!"

Actually physically putting a chemical which tortures into me used to be performed by putative nurses. Other accomplices work for the same putative-university putative hospital. Other accomplices work at the same putative university or for our laboratory (namely LIP - Laboratório de Instrumentação e Física Experimental de Partículas). (Legally this laboratory is not part of the University of Coimbra and this laboratory's headquarters are located circa two hundred kilometres away from this university.)

This putative university and laboratory in bad faiths used the Portuguese Foundation for Science and Technology to use a scholarship as bait to send me on a wild-goose chase into a trap in torture chambers.

Essential accomplices are a public prosecutrix who signed a court order with a court judge. This torture had not been commenced before this compulsive-commitment has been signed. Other accomplices are other court employees.

They violate: a European "**Convention for the Protection of Human Rights and Fundamental Freedoms**

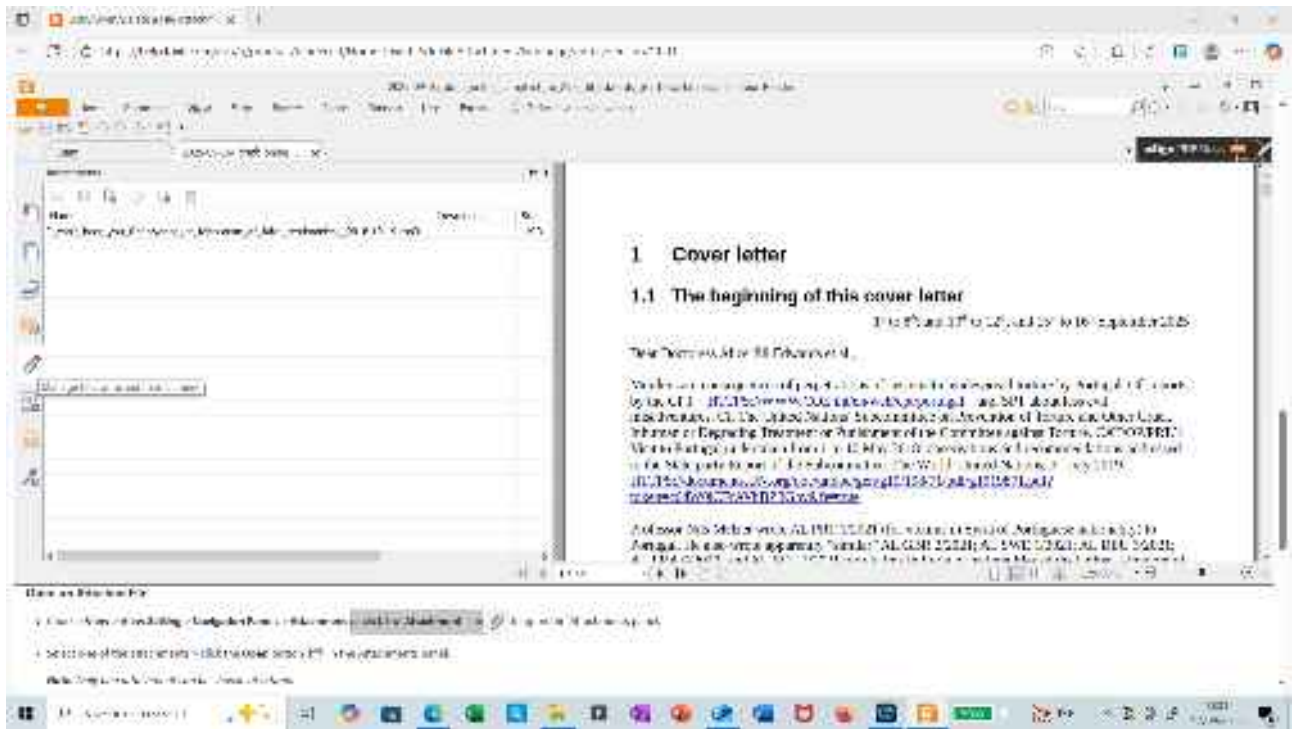
