

• A Trim District judge had a hearing with me on 24th March 2026. So <1 month is left for a judicial review.

• This Courts Service never uses an interpreter for me. No judge ever speaks in Irish with me. This dishonest Courts Service lies about interpreters. Cf. “8.5 Strategic Priority 5: Facilitating the use of Irish language in court proceedings

Context to action

As provided for in Section 8 of the Official Languages Act 2003, any person who appears in court has the right to use Irish or English in their interactions. • This hearing of 24th March 2026 is about Ashbourne police station on 13/09/2025: i.e. I myself as a litigant in person brought a summons for 24th March 2026 against Police Sergeant Anthony Malone MH254. I simultaneously brought summonses for 24th March 2026 against criminals against whom I attempted to complain to Sergeant Anthony Malone MH254 on 13/09/2025. These summonses are [2026-03-13i_Summons_No_15-1.odt](#) (I put lines through different defendants’ names on different hard copies, such that 1 hard copy does not have a line through “Antoin ó Maoileoghain” [Irish for Anthony Malone], whereas a different hard copy does not have a line through “Leas Portaingéalach Sóisialta”; and so on for all names). - A friend listened to this hearing. He said that it is not a hearing!

1.1 deliberate delays

- Solicitors who are not in positions to be instructed over this misadventure had advised me before 27/04/2026 that I need to appeal. Such a solicitor had said that possibly I would need a judicial review later. Instead, this Courts Service has informed myself for the 1st time on 27/04/2026 that I need a judicial review and that I cannot appeal against an inexistent order.. Cf.

- This judge does not identify herself to me. Her identity became confirmed to me for the 1st time on 27/04/2026: i.e. >1 month after this hearing. She is called District Judge *Éirinn* McKiernan.
- District Judge *Éirinn* McKiernan and this Courts *Dis*-Service deliberately in bad faiths frustrate due processes.
- The Language-Commissioner staff can confirm that Irish versions of Forms 15.1 and 15.3 continue to not be available despite this Department of fake Justice and this Courts Service makings commitments for forms for me to be available in Irish since many months ago.
- This district judge; this Courts Service; police officers; and this Department of fake Justice perpetrate frustrations.
- They delay me by their dishonest refusals to act in timely manners.

1.2 Crimes for which there is no legal discretion to refuse to prosecute against

The annual reports of the Judicial Council report that only one complaint alleging judicial misconduct was ever declared to be admissible. No such annual report discloses the identity of any solicitor - if any - involved in that case. Therefore I do not know whom to instruct at the Judicial-Conduct Committee.

I brought criminal-private-prosecutions forms

This conversation with a district judge lasted barely 56 SECONDS (not minutes)!

Inter alia the 6th page de

clearly quote neglect of duties; persecution; discrimination; harassment; hatred; connivances; and discreditable conduct.

The 13th page de

clearly quotes an ambassador who wrote that I could complain to local authorities.

The 14th page de

“Please read "Report to the Portuguese Government on the periodic visit to Portugal carried out by the European Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment (CPT) from 23 May to 3 June 2022"

(which is based on an interview with me after I was tortured)”.

Portugal murdered 2 of my friends and another neighbour to cover up torturing me in 2013.”

N.B. these laws forbid any discretion to refuse to act against torture.

I.e. these individualised versions are not by using a computer to make new versions.

1.5 victimisation and language discrimination

This Courts Service boasts that it provides interpreters. The Language-Commissioner staff must respond in English to writings in English. Cf.

1.7 precedent de assailant convicted in circa 3 years and ordered to pay 5000Euro compensation

This district judge refuses to sign a summons against an assailant who perpetrated actual hits against me in front de a CCTV camera.

Contrast with a precedent. Convicted Criminal Michael Kelly did not actually even touch Victim Paul Keane when Michael Kelly assaulted Paul Keane in March 2023. Judge Orla Crowe at Dublin Circuit Criminal Court sentenced Michael Kelly over that assault on 13/04/2026.

Judge Orla Crowe said that that contactless assault was "unacceptable" and "reprehensible behaviour".

1.9 dialogue during this hearing; and acts cited

"Good afternoon." said District Judge *Éirinn* McKiernan to myself as a litigant in person on 24/03/2026 at 1:38p.m.

"Eh. Bíonn eh síniú eh le breitheamh uaim le do thoil." said I myself i.e. a litigant in person.

"So. So. So you're asking me to issue these summons." said District Judge *Éirinn* McKiernan.

"Eh tá eh. Eh. Eh. Tá seo ag teastáil uaim." said I myself.

"Yeah, good afternoon." said this Anglophone judge misinterpreting Irish "uaim." to be English "afternoon." as this Courts Service scheduled this hearing for 10a.m. (i.e. this inept lazy judge waited some 3 hours and 37 minutes for calling me)!

"Now having considered these matters and I've looked at the summonses and I do not believe that there is any legal basis to issue them and I'm refusing to issue them under the act. Thank you." said lying Anglophone District Judge *Éirinn* McKiernan in English about summonses written in Irish. Furthermore, this documentation cites many acts so what does she mean by "the act"? E.g. this documentation refers to: European Conventions on Human Rights (of the Council of Europe); the Equal Status Acts 2000 to 2015; "[a\[n\] 1984 UN Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment.](#)"; the Policing, Security and Community Safety Act 2024; the STANDARDS IN PUBLIC OFFICE ACT, 2001; [CRIMINAL JUSTICE \(UNITED NATIONS CONVENTION AGAINST TORTURE\) ACT, 2000 \(\[HTTPS://WWW.IrishStatuteBook.ie/eli/2000/act/11/section/2/enacted/en/html#sec2\]\(https://www.irishstatutebook.ie/eli/2000/act/11/section/2/enacted/en/html#sec2\) \); the *Petty Sessions \(Ireland\) Act 1851* \(](#)

"Conas?" said I myself as an unanswered data-subject-access request.

"I I'm refusing to issue them. Thank you." said this criminally conniving District Judge *Éirinn* McKiernan.

"Cén fáth?" said I myself as an ignored unanswered data-subject-access request.

"So the next matter then is [. . .]" said a court blonde.

1.10WRC ESA criticism against a policeman

- I myself (i.e. sans lawyer sans interpreter sans dictionary) wrote a criminal complaint about 2 murders and torture as registered mail in English and German (and quoting exact crimes' names in Portuguese from a criminal code) namings 2 victims (viz. *Jorge Albano Esteves da Silva Fernandes* and *Hugo Alves*). I wrote this criminal complaint by registered mail in 2019 but it became responded to in 2024 only! A response in Portuguese is by 2 police officers apparently refusings to investigate because they pretend that murders and torture are not a crime! These police officers are named ***David Melo da Silva Alferes (Comandante do Destacamento Territorial de Coimbra, em Suplência)*** and "***Redator: RP***".

- Police Sergeant Anthony Malone refuses to investigate so he assaulted me when I brought complaints in front of a CCTV camera at a police station on 13/09/2025.

- **I myself started a conversation in this Ashbourne police station in Irish because of torture while I had documents about crimes and autism on 13/09/2025. "Haigh. Eh. Bíonn caingne uaim."** [≈ Hello. Eh. I need to make complaints.] **said I myself on 13/09/2025.**

"Is this is this about something - sorry to interrupt you. Is this about something over in Spain or [. . .]" said a policeman (not Defendant Malone).

"So, eh, please eh register a complaint and eh inform eh a Portuguese police force em that I'm making a complaint here." said I myself.

- "**But but you keep coming into the guards. We keep telling you we're not able** to do that." said a policeman (not Defendant Malone). I visit this Ashbourne police station e.g. before 1998; in 1998; after 1998; and on 25/06/2013; 11/07/2013; 16/07/2013; 22/07/2013; 14/07/2023; 20/07/2023; 22/07/2023; 23/07/2023; 27/07/2023; 07/08/2023; 12/10/2023; 03/01/2024; 28/11/2024; and 13/09/2025. An embassy said in 2016 that Defendant Malone knows about me.

"Your website clearly states that you must accept complaints about crimes which happened abroad [. . .]" said I. Cf. • "So. Eh. Lots of crimes have happened. Eh. Two of my friends have been murdered in Portugal and another neighbour. [. . .]" said I.

"But are the Portuguese police not investigating murder?" said a policeman (not Defendant Malone).

• "I do not detect them investigating murders." said I myself.

"And for example I have received eh an email from eh two guards in Portugal in Portuguese even though they know I don't understand Portuguese and it seems according to translation websites to say that they deny that murders are a crime." said I myself.

• **"No. Murder is a crime alright." said Defendant Malone.**

• **"Where are you from originally though?" said Defendant Malone.**

"Well supposedly here." said I myself.

"You're Irish." said Defendant Malone, grammatically not as a question but I interpret how he said this sentence to have a questioning intonation.

"So far as I know." said I myself.

"Were you born here?" said Defendant Malone.

"Supposedly yeah." said I myself.

• **"Do you not know where you were born?" said Defendant Malone.**

"I don't remember my birth. I could be a kidnapped Lithuanian for all I know." said I myself because Malone persisted about impossible-to-know data.

"Get out. Go on. I asked you where you are from. You come in here telling me you could be kidnapped from Lithuania." said Defendant Malone falsely: I came in before 6:55p.m.; he ejected me shortly before 7:04p.m. (i.e. MANY MINUTES AFTER I CAME); and I never volunteer to say where I am from.

"How am I supposed to know where I am from?" said I myself.

"Get out! Get out of my station! Get out! Get out! [. . .] Out you go! You don't know where you were born. Get out. Get out." said Malone.

"I didn't assault you." said Defendant Malone falsely on 13/09/2025.

"I was being nice to you." said Defendant Malone falsely on 13/09/2025.

• **Defendant Policeman Malone perverts the course of justice. Policeman Defendant Malone perpetrates obstruction of the administration of justice. I suffer sleep deprivations because of him.**

• **Defendant Policeman Malone is guilty of torture via connivances.**

• **Policeman Defendant Malone is xenophobic. Defendant Policeman Malone is guilty of hatred.**

• **Defendant Policeman Malone harassed me.**

- Defendant Policeman Malone is guilty of discrimination and persecution.
- Defendant Policeman Malone is guilty of neglects of duties.
- Defendant Policeman Malone is guilty of discreditable conduct.
- Defendant Policeman Malone is guilty of being an “9. Accessory to conduct specified in this Schedule, that is to say, conniving at or knowingly being an accessory to such conduct.” as specified by *GARDA SÍOCHÁNA (COMPLAINTS) ACT, 1986*.
- Defendant Policeman Malone is guilty of wilful neglect or default.
- Defendant Policeman Malone is guilty of abuse of office.
- Defendant Policeman Malone is guilty of subsidies frauds according to *PROHIBITION OF INCITEMENT TO HATRED ACT, 1989*.
- Consider the *Ethics-in-Public-Office Acts!*
- Consider the *STANDARDS IN PUBLIC OFFICE ACT, 2001!*
